The undersigned understands that he/she and beneficiaries, executors, and assigns will be entitled to the benefits of insurance coverage provided by the Port Royal Speedway for accidental injuries or death which occur as a result of external, violent, and visible means sustained during Port Royal Speedway events. The coverage of said policy shall constitute the limit of liability of Port Royal Speedway for such injuries occurring to the undersigned in any Port Royal Speedway event provided proper notification is filed with Port Royal Speedway management prior to that person leaving speedway property. **The undersigned fully understands that a race car exposes him / her to risks that can lead to serious bodily injury or death. The undersigned voluntarily assumes these risks.**
