OVERNIGHT CAMPING REGULATIONS

1. Overnight camping shall be permitted only in certain areas of the property.
2. J.C.A.S. has overnight camping in 3 locations of the property.
3. 1st location is in the lower end of the grounds, with full water, sewer and electric hook-ups. The rate is **\$900.00 per season. PAYMENT IN ADVANCE!**
 - A. This location requires the camper to be responsible for the mowing of the grass while being occupied to a height no greater than 4".
 - B. These long-term camping spots are not available to rent from 1 week prior to the Juniata County Fair thru 1 week after the fair.
4. 2nd location is in the field across the road from the racetrack in rows 2 & 3 with no water and/or sewer services. This location has electric service only. Various rate options apply. **PAYMENT IN ADVANCE!**
 - A. If you get caught sharing electric service, you will be suspended for one year.
 - B. If your camper is parked at this location, you will be charged whether you are using the electric service or not.
5. 3rd location is in the field across the road from the racetrack in rows 1,4,5,6. This camping has no hookups and is free except for big races and fair week.
6. No overnight camping is permitted on any other portions of J.C.A.S. property without permission and then must also comply with these rules and any other rules applied at that time for an additional location.
7. No Campfires are permitted within the Port Royal Borough.
8. **NO LOUD MUSIC** or Boisterous Behavior during or after the event and/or race.
9. Quiet time is 12:00am(Midnight).
10. All motorized golf carts, 4-wheelers, scooters and handicapped scooters, may be used in the camping areas. All must be maintained to a safe operating speed not to exceed 10 mph. All the above units **will not** access the road that runs directly behind the Main Grandstand.
 - A. During the Juniata County Fair, no motorized golf carts, 4-wheelers, scooters or handicapped scooters will be allowed, except those being used by J.C.A.S. Fair Board Members.
 - B. Liability Insurance will be required and will be verified for the above that are driven on our property outside of the pit area. A copy must also be given to the office for our records.
11. All trash must be placed in the trash barrels located in the camping area. Positively no waste dumps on J.C.A.S. property. **VIOLATORS WILL BE PROSECUTED!**

12. Possession and consumption of alcoholic beverages are subject to the Laws of Pennsylvania. Under no circumstances are any alcoholic beverages to be left behind.
13. J.C.A.S. management reserves the right to limit space taken by any and all campers. This will be strictly enforced in all locations.
14. J.C.A.S. reserves the right to refuse entrance to any camper.
15. J.C.A.S. assumes no responsibility for damage, theft, or loss of any kind, to any and all property of campers. Juniata County Ag. Society Management hopes that all camping guests have a safe and enjoyable experience.
16. Dogs are welcome but must be kept on a leash at all times and cleaned up after. Dogs are NOT permitted in the grandstand area.
17. No refunds will be issued for camping.
18. Campers are not permitted on the grounds during Off-Season, November 1-March 1
19. Due to Port Royal Borough Code, you may not come into the field any earlier than the day before a race and must be out by noon the day after. The field will be locked at noon the day after the race and any remaining campers will be towed at the owner's expense
20. Also, campers must be pulled straight in or backed in, no boxing
